3. Public Comments/Questions -

A. Public Comment

Susan Comerford - We love our teachers and we love our school board members, commended board for hiring Superintendent, creating new/ better systems, devoted member of faculty at UVM, encouraged both sides to go back to the negotiating table

Thea Knight - We know teachers work hard, doesn't understand why teachers aren't accepting the 2% raise, be cognitive about what the community can afford

Fran Brock - teacher at BHS, BEA President, teachers voted to strike today, teachers can not sit and be still about the treatment, teachers to strike by October 20th, thank the community, PTO groups, Board needs to come back to the table

Chris Hood - Treasurer of BEA, thank the board for being here tonight and thank the people for moving the location, Asks everyone to listen to their voices about moving forward, have an open mind moving forward, have new negotiating styles, asks all parties to talk and negotiate,

JB Barna - Parent of 8th grader at Edmunds, talked to people on both sides, conclusion is that this is hard, sad, the tension is complicated, seems there is not an easy answer, at core we are all very good people, selfishly doesn't want teachers to strike, wants people who are negotiating to look for common grounds

Alison Segar- A parent in the school district, tax payer, 38 years a union member, pro union, believes teachers deserve good pay, trust school board that there is no more money, please come up with peaceful resolution

Ashley Smith- Lives near BHS, cares deeply about kids, has talked to BHS teachers who say they don't get breaks

Ben Bosher - speaking on behalf of his neighbors, health care costs have risen, no one benefits by a strike, encourages BEA to accept the contract, says friends have not been given such a raise

Commissioner Cina made a *motion to extend public comment*/Commissioner Curry second motion

Passes extend Public Comment by 12 minutes

Karen Ruben - email board members all the time, knows that there is not evil intent, knows that everyone engaged in this has good intentions

Pete Wyndorf - Strike has been forced upon for teachers, go back and agree to give back more professional development money, go back to the table, keep talking,

Matthew Gordon- UVM Student, The school board imposition implies that there is no money for our students

Nolan Rampy - Address the money issue, the fact is the money is there but schools are not a priority, the mayor is spending millions on a new mall, addressed teachers - by making a stand the rest of the state teachers will stand and fight

Isaac Krebman - Burlington resident, current student teacher, saw colleges pour heart and soul into teaching, when teachers are under attack it is not good for our most vulnerable, give teachers a fair contract

Jess Fuller- a lot of great speeches here tonight, taxpayer in Burlington, a lot of people have shown up, seeing a lot of green shirts and community members

Lucy Gluck - long term resident of Burlington, wants to be proud of Burlington, glad to hear that you're going back to the table next week, feels like if we don't come up with solutions we are going to lose a lot of really good people

Joe Patalano - I ask the school board and Superintendent what are you teaching our students when you walk away from the table? You walk out because you can't get your way, the board hired this Superintendent to break the Union. The process is corrupt

Mike Fisher - President of Champlain PTO, has advocated so there is not a strike, a lot of hurt feelings, encourages both sides to go back to the table next Wednesday to go in with your heads not emotions, All need to act together, this is a shared responsibility.

Nancy Rondeau- came here in 1970, two students graduated from BHS, Wants to remind you to google the past strike, and see how it tears a town apart, works with students with Special needs

Jeff Wick - before the board imposed believes that the two sides were very close, mentioned the salary grid, move money to increase tuition reimbursement, believe there can be an agreement

Isaac Jenerman - Sophomore at BHS, failed negotiations has interrupted students, A strike will affect students by possibly extended year

Commissioner Cina - A social worker, values relationships, these relationships have been damaged, believes we can reach a settlement, shared quotes about healing relationships

Student Rep Jacob Bucci - Sad about both sides, has heard blatant insults from the board and the teachers, asks the teachers and board to go into negotiations with open minds
