





Q3 What best describes your affiliation to the Burlington School District? Click all that apply.



As I understand it, the Burlington community sees to see a tax increase over just over 7% without increasing and programs or services and that were we to increase any services, staff or programs, we would see an additional increase of at least 2%. My partner and I are not wealthy by any means, but we do own our home and we pay taxes. I assume that you are hearing from many people in our community who are against an increase in education-related taxes at all. People are rightly frustrated (and/or confused) by the state education budget formula and can't imagine why we would need to increase our taxes at all, let alone by 7% or 10%, but that frustration and anger doesn't mean that an additional tax burden isn't the right thing to do for our students. I am writing to strongly advocate for placing forth a budget which includes additional services and supports. The needs of our schools far exceed our current capacity. I very concerned with the way the current budget fails to meet the needs of our students, especially those at IAA & SA. Article after article talks about how, nationally, students are more stressed, more anxious, more in need of services now than at any time in the past. Vermont children are at least as deeply affected as those in other parts of the country. In Burlington, the needs are even greater for many reasons, including the high numbers of second-language learners and increasing amounts of trauma in families. If you need evidence of this, I urge you to talk to our principles, staff and teachers. Visit a classroom if you haven't already. The biggest need, at least as it appears to me based on my classroom visits, is for paras in Kindergarten and the need for additional support staff. Not only are our most frail students missing out on learning, but those in the middle and top performers are too -- unmet individual student needs in the classroom affects all students. We cannot continue to educate our students without increasing our supports. Of course, there are additional needs, such as upgrades to IAA's HVAC system (it's so loud students and teachers often cannot hear each other), and improvements to the physical space to ameliorate hazards to physical safety on the playground, but it's the need for additional supports that I hope you're most aware of.
