What is the overall <a href="#">deductible</a> ?	\$1,800 individual / \$3,600 family.  <a href="#">Co-insurance</a> and <a href="#">co-payments</a> do not apply to the <a href="#">deductible</a> . This benefit combines your prescription drug and medical <a href="#">deductibles</a> .	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount each <a href="#">plan</a> year before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay. Are there services covered before you meet your <a href="#">deductible</a> ?
