

Cash-In-Lieu (CIL) Rates for FY23

- The annual Cash-in-Lieu (CIL) payment amount is divided into TWO payments, which are paid during the last week of December 2022 and the last week of June 2023.
- CIL must be elected annually during open enrollment in order to be eligible for the following calendar year.
- For new hires, CIL is prorated based on the date the employee becomes benefit eligible.
- CIL rates are set based on the Master Agreements. For more information, please refer to your Master Agreement.
